All items are offered "AS IS, WHERE IS" without any warranty expressed or implied as to the condition of the said property. Please inspect the equipment prior to bidding.

ALL SALES ARE FINAL

It is the sole responsibility of the successful Bidder (Buyer) to pay in full and to guarantee said payment to the auctioneer by the conclusion of the auction day by cash, credit card, or certified bank funds.

A Buyer's premium of 15% is applied to all purchases (with a 3% discount to Buyer's premium for payments made in cash). There is a sales tax of 6.35% for the State of Connecticut collected on the sales as well.

Removal is at the Buyer's expense; responsibility for said removal in that liability for any damages caused to the purchased property, to the Seller's property or any bodily injury caused to the Buyer or other persons, is born upon the Buyer. Any purchased property which requires disconnection of power, gas lines or plumbing is done so at the Buyer's responsibility and liability; all disconnections should be left in a safe manner: wires capped, gas or plumbing lines shut down and leak free. Any openings created in any building structure must be closed in a weather tight, safe manner.

Removal can begin upon full payment of items or as otherwise permitted by the Auctioneer. Removal times are day of sale or announced or agreed to by the Auctioneer at the time of sale. All items not removed by the specific date shall bear upon the Buyer any expenses for storage, removal or disposal as deemed necessary by the Auctioneer. Buyer is responsible for removing and loading of auction items purchased.

ONCE AN ITEM IS DEEMED "SOLD," THE BUYER HAS SOLE RESPONSIBILITY FOR THAT ITEM. ADAMS AUCTIONEERS // APPRAISERS IS NOT RESPONSIBLE FOR STOLEN OR DAMAGED ITEMS.
